Hearing none the clerk asked for the vote by a show of hands. Motion carried with 5 ayes 0 Nays. The Clerk called for the vote of Mary Jones as moderator. Motion carried with 5 ayes 0 Nays. The clerk then administered the Oath of Moderator.

Sherrill Knorr brought up the approval to sell township property on Bergera Street. It is a vacant buildable lot that is in a residential area. All the township does is mow the grass and pay Claypool Taxes on it of \$10. Mary Jones make motion, seconded by Sherrill Knorr. No discussion. Vote 5 yes, 0 no.

Sherrill Knorr brought up declaring the old tables and Chairs from the hall as surplus. Would like to donate to the Lions. Motion made by Adam Beaty and seconded by Scott Favero. No discussion. Vote yes 5 no 0.

Sherrill Knorr proposed the construction of a Pavilion on the Township property. A discussion insured as to cost to residents. Sherrill stated she would like the public to be able to use it free of charge; if someone wanted to reserve it, we could post notices. Motion made by Adam Beaty to approve the construction of a pavilion seconded by Steve Bolatto. Discussion that bids would have to go out. Vote yes 5, no 0.

Sherrill Knorr proposed a construction of a playground by the pavilion. A discussion occurred as to if it would be accessible to all children. Sherrill Said that it would be ADA approved. Motion made by Mary Jones, second by Adam Beaty to approve a playground. No further discussion. Vote taken yes 5 no 0.
