- Our biggest thing was House bill 5050 that would eliminate road districts, park districts, mosquito abatement districts, water districts, etc.; and we are very much opposed to this at the township level.
- They were on their third amendment to this bill, and it was in committee and passed it, but went to the house floor and it was not called for a vote. She said they were going to let it ride to see how we all do on the decennial reports.
- They are looking to reduce the size of local government by 10-20 percent.

### **Highway:**

- Commissioner Dixon reports they have started mowing.
- Took all the wheels off the big truck, cleaned and painted them and did other maintenance.

The highway bills were presented.

A motion was made by Trustee Tessler to approve the Highway Commissioners report and seconded by Trustee Corbin.
