July 26th, 2023 Meeting Minutes

The Reed Township Board meeting was called to order by Supervisor Sherrill Knorr at 4:30 pm.

The Pledge was said by all.

Those present at roll call were Trustee Scott Favero, Trustee Steve Bolatto, Trustee Pam Tessler, Trustee Adam Beaty, and Supervisor Sherrill Knorr. Also present were Highway Commissioner John Dixon, Assistant Clerk Debra Lavicka, and Township Clerk Tom Nahas.

A motion to approve the June minutes was made by Trustee Beaty; seconded by Trustee Bolatto. There was no discussion; all in favor, with Trustee Beaty abstaining, motion carried.

Treasurer Report:

It was noted that we received the balance of levy money from Constellation.

A motion to approve the Treasurer's report (Account balances for May) was made by Trustee Favero; seconded by Trustee Tessler. There was no discussion; all in favor, motion carried.

Town & General Bills:

A motion to approve the bills for Town and General was made by Trustee Bolatto Second by Trustee Tessler. No further discussion, all in favor, motion carried.

Supervisor Report:

- Junior Comets had a fundraiser and we donated 2 free hall rentals.
- Going to supervisors' meetings at the state and they have some bills in the works.

Highway:

Commissioner Dixon announced that he put out for bids to cover a mile of road with inch and a half overlay with shoulder stone and striping out by Sportsmen's Club and the Bohemian Cemetery. Then out to Kankakee Street to put shoulder stone on.

Three companies submitted bids: D Construction, P.T. Ferro, and Gallager.

A motion was made by Trustee Beaty to approve the Highway Commissioners report and seconded by Trustee Bolatto.

A roll call vote was taken; the motion was carried with all in favor.
