

TAX LEVY ORDINANCE

ROAD DISTRICT

ORDINANCE NO. 11262024-B

An ordinance levying taxes for all road purposes for REED Road District WILL County, Illinois, for the tax year 2024 , collectable in 2025.

BE IT ORDAINED by the Board of Trustees of REED Township, WILL County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of REED Road District on NOVEMBER 26, 2024 does hereby determine and declare that the sum of TWO HUNDRED SIXTY THOUSAND Dollars (\$ 260,000) are hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purposes as:
